About some of the terms we use in this document

There may be some terms we refer to in the document that you may not be familiar with. Here are the meanings of these terms.

| TERMINOLOGY | DESCRIPTION |
|------------------------------------|---|
| Benefit year | A benefit year refers to the benefits a member is entitled to during a calendar year, that is to say 1 January to 31 December. This medicine list (formulary) and Chronic Drug Amounts are applicable for this benefit year only. |
| Chronic Drug Amount (CDA) | The Chronic Drug Amount is the monthly amount that we pay up to for a medicine class. This amount is subject to a member's plan type. It applies to chronic medicine that is not listed on the medicine list (formulary). |
| Discovery Health Rate for Medicine | This is the rate that we pay for medicine. It is the Single Exit Price of medicine plus the relevant dispensing fee. |
| NAPPI code | This is a unique identifier for a given medicine, surgical or consumable product. |
| Single Exit Price (SEP) | Single Exit Price (SEP) is the price at which a pharmacy buys medicine from a wholesaler. This price is regulated by the government and a medicine may not be sold by a wholesaler at more or less than the published SEP. |
