Explanation of terms

Active ingredient

This is the main substance in a medicine that is responsible for the clinical action on a human body.

Benefit year

A benefit year refers to the benefits a beneficiary is entitled to during a calendar year - from 1 January to 31 December of that year.

This medicine list (formulary) is applicable for 2025 only.

Medicine class

This describes medicine that have similar chemical structures or similar therapeutic effects.

Prescribed Minimum Benefit conditions (PMB conditions)

These are conditions which all Medical Schemes are required to cover in terms of the Medical Schemes Act (No 131 of 1998), in any setting, according to clinical guidelines.

Reference Price

The Reference Price is a set monthly amount we pay up to for a medicine category. This applies to medicines that are not listed on the medicine list (formulary).

Ready-to-hang (RTH)

A feed that comes in a sterile, pre-filled formula container (typically 1 litre) that is spiked by the feeding tube, and then fed to the patient via a feeding pump.
